

**SUMMARY ANNUAL REPORT FOR
KRISPY KREME DOUGHNUT CORPORATION WELFARE BENEFITS PLAN**

This is a summary of the annual report of the KRISPY KREME DOUGHNUT CORPORATION WELFARE BENEFITS PLAN, a health, life insurance, dental, vision, temporary disability and long-term disability plan (Employer Identification Number 56-1318322, Plan Number 501), for the plan year 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

KRISPY KREME DOUGHNUT CORPORATION has committed itself to pay certain claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with FIRST UNUM LIFE INSURANCE COMPANY, PROVIDENT LIFE AND ACCIDENT INSURANCE COMPANY, AMERITAS LIFE INSURANCE CORP., Lincoln National Life Insurance Company, EYEMED VISION CARE on behalf of Fidelity Life Insurance Company and Prudential Insurance Company of America to pay certain ISWL STND, Life insurance, Dental, Long-term disability, Temporary disability, Vision, Accident, Hospital, Critical Illness, AD&D, Vol Life, CRITICAL ILLNESS, Hospital Confinement claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$2,886,842.
